Valérie Rouxel-Laxton

Head of Economic and Financial Affairs Delegation of the European Union to the United States in Washington D.C.

Valérie Rouxel-Laxton is an Economist and heads Economic and Financial Affairs at the Delegation of the European Union to the United States in Washington, DC. She is responsible for analyzing and reporting on macroeconomic developments in the US and European economies, and representing the European Union on economic matters in the US.

Before coming to Washington, she worked for the European Commission's economic service in Brussels, specializing in international economic issues, forecasting, and European integration. In this capacity she has written and delivered presentations on a number of economic issues, including the current economic situation, global imbalances, and labour market developments. She holds a PhD in international economics from the Graduate Institute in Geneva, and a Master of Science degree in Political Science and International Relations from the Institut d'Etudes Politiques, Lyon.

Mario Buisán

Trade Commissioner

Embassy of Spain – Trade Commission Miami

Mr. Buisán is the Trade Commissioner of the Embassy of Spain in Miami, Florida. He is responsible for commercial promotion of Spanish goods into the US market, and strengthening business relations and Spanish investments in this area. From 2004 to 2009 he was Director General of Information and Investments at the Spanish Institute for Foreign Trade (ICEX). Prior to this he was Deputy Director General of International Affairs at Banco de España. He also worked at the MIGA Agency of World Bank. He was a former Trade Commissioner of Spain in Düsseldorf, Germany and has occupied several positions in the Ministry of Economics and Finance. Mr. Buisán was an Associate Professor of Applied Economics at Carlos III University in Madrid and a Professor of Law at the Instituto Nacional de Administración Pública and at the Centro de Estudios Comerciales. He was also a member of the Administration Council of SAECA; a Counselor of Compañía Española de Financiación del Desarrollo, S. A. and of the Sociedad Estatal Española P4R, S.A.. Mr. Buisán holds a double Major in Economic and Business Sciences, and a Law Degree. He is a member of the Commercial and Economic Technical Personnel Organization of the Spanish Government. He often lectures in several forums about the globalization of the Spanish economy and businesses. He has written several articles on business and economic globalization; financial, commercial and European Union interests.

Sophie Delporte

Head of the Public Affairs Department Consulate General of France in Miami

Ms. Sophie Delporte is a former student of the Regional Institute of Administration of Lille, France and a Graduate of the Institute of Political Studies -Sciences Po- of Paris.

As a Foreign Secretary, she has been appointed on August 7, 2009 at the central administration in the Department of French Citizens overseas and Consular Administration (Paris, France), where she was in charge of anti tax evasion agreements.

Ms. Delporte served in the Cabinet of the French Foreign Minister from February to May 2012, as an advisor for Legal and Judicial Affairs, Human Rights and the French Citizens overseas.

In September 2012, she joined the Consulate general of France in Miami as the Head of the Public affairs Department.

Consul General Simone Filippini arrived in Miami Florida on August 1, 2011. In the past four years she served as the Ambassador of the Kingdom of the Netherlands in Skopje, Macedonia. She started her career in the Foreign office in 1988 in The Hague, after having worked as a conference manager in a commercial company.

As a career diplomat Ambassador Filippini previously served as the Head of the Gender Department; Leader of the Project Team responsible for setting up a governmental communication strategy on European Integration issues; Coordinator of EU Enlargement; Senior Staff in the Political Department supporting the Director-General for Political Affairs; Deputy Head of the Desk for the Middle East and Gulf Regions; and as desk officer special programs with NGOs.

The Consul General received an MA in Slavic Languages and Literature from Utrecht State University in the Netherlands. She is also an accredited communication and public information expert. Ambassador Filippini has also been active as an elected member of the National Board of one of the Dutch political parties, holding the international portfolio; as member of the Board of the Netherlands Institute for Multi-Party Democracy, and as President of the Board of NOVA International School in Skopje, Macedonia. Moreover she was actively involved in the founding of several professional networks.

In 2010 Ambassador Filippini was awarded the Diversity Award Ministry of Foreign Affairs, the annual MFA management award. Also, she received several awards during her assignment in Macedonia for her personal contributions to the promotion of the environment, film and contemporary dance.

She worked as a Research and Teaching Assistant in the Economics Branch of Management Engineering Department at ITU during 2002-2005. Her main research interests lie in the fields of labor economics, development economics and the economics of gender. Dr. Rebecca Friedman

Rebecca Friedman, Co-Director of the MEUCE, is Associate Professor of History and Director of European Studies at Florida International University. Her research focuses on gender and the family in modern Russian in the context of Russia's relationship to modern European institutions and ideologies, with a special emphasis on masculinity, domestic interiors, and childhood. She is the author of *Masculinity, Autocracy and the Russian University*, 1804-1863 (Palgrave/MacMillan, 2005) and (with Barbara Clements and Dan Healy) the collection *Russian Masculinities in History and Culture* (Palgrave, 2002), which is the first volume in English to focus on the growing field of Russian masculinity studies. She just co-edited *European Identity and Culture* (Ashgate, 2012) with Dr. Markus Thiel. She is currently working on a monographic study of gender, childhood and the domestic interior from the middle of the 19th century through the first decades of Bolshevik rule.

He has published over 200 academic articles and reviews, and he is the author or editor of 39 books, among them *Cuba, the U.S. and the Helms-Burton Doctrine: International Reactions* (University of Florida Press, 2000), *Las relaciones exteriores de la Unión Europea* (México: UNAM, 2001), *Retos de la integración regional: Europa y América* (México: UNAM, 2003), *La Unión Europea y el TLCAN* (México: UNAM, 2004), *The European Union and Regional Integration* (Miami: EU Center, 2005), *La Unión Europea y la integración regional* (Buenos Aires: CARI/ U. Tres de Febrero, 2005), *Towards the Completion of Europe* (Miami: EU Center, 2006) and *A Historical Dictionary of the European Union* (Scarecrow Press / Rowman & Littlefield, 2006), and *The dollar and the euro* (Ashgate, 2007). He has also published over 1,400 columns and essays. He was awarded the *Encomienda* of the Order of Merit by King Juan Carlos of Spain.

Tim Shaw, PhD, Princeton Universit, joins the Department of Conflict Resolution, Human Security, and Global Governance at the beginning of the fall 2012 semester as graduate program director of the new Global Governance and Human Security PhD program. He has an extraordinary record, both as a scholar and administrator, most recently as professor and director at the Institute of International Relations at the University of the West Indies, St Augustine in Trinidad; associate research fellow at UNU Comparative Regional Integration Studies in Bruges; and senior fellow at Centre for International Governance Innovation at the, University of Waterloo.

Shaw previously directed the Institute of Commonwealth Studies at the University of London where he remains emeritus professor. And he continues to be visiting professor at Aalborg, Mbarara, and Stellenbosch Universities.

Shaw edits of the international political economy book series for both Ashgate Publishing (www.ashgate.com/ipenr) and Palgrave Macmillan (www.palgrave.com/ipe). His most recent co-edited works include *Diplomacies of Small States* (forthcoming in 2013), *Africa & IR in the 21st Century* (2012), *Rethinking Development Challenges for Public Policy* (2012), *Ashgate Research Companion to Regionalisms* (2011), and *Inter-American Cooperation at a Crossroads* (2011).

In addition, Dr. Thiel is a research associate at the Miami European Union Center of Excellence and active in FIU's European Studies Program.
